PLEASE READ MOST CAREFULLY BEFORE INSTALLATION!

This is a legal agreement between end-user and **microtap GmbH**, Rotwandweg 4, D-82024 Taufkirchen, Germany. By installation of this program the end-user is agreeing to be bound by the terms of this agreement. If you do not agree return the disk and the accompanying items (including written materials and binders or other containers) to the place they were obtained for a full refund. The enclosed microtap product is a single user version unless your product's packaging indicates otherwise or unless you have a written agreement with microtap.

1. GRANT OF LICENCE

- (a) microtap grants the end-user a license to use one copy of the enclosed software program („the Software“) on a single terminal connected to a single computer (i.e. with a single CPU). The end-user may copy the software from one single terminal to another such single terminal or portable or home computer or terminal belonging to or used by the end-user provided that the Software is in use on only one computer at a time and is never installed on more than two computers at any time and is used only by the end-user.
- (b) If the end-user has multiple licenses for the Software, then at any time the end-user may use as many copies of the Software as the end-user has licenses. If the number of persons who can access and use the Software exceeds the number of licenses that the end-user has, the end-user must have a reasonable mechanism or process in place to assure that the number of persons using the Software at the same time does not exceed the number of licenses.
- (c) This license is not a sale of any of the rights of ownership of the original Software or any copy. In particular microtap retains title and full rights of ownership in the original or any copy of the Software installed or copied or in use on all such physical media or on any other media such as, but not restricted to, floppy or hard disks, CD-ROM or similar storage devices or operating memory.
- (d) The Software is copyrighted and for the avoidance of doubt the following are absolutely prohibited without the express prior written consent of microtap a) Unauthorized copying of the Software, including Software that has been modified, merged, or included with other software; b) Translating any of the Software; Reverse-engineering, disassembling, decompiling, or making any attempt to discover the source code of any of the Software; c) Sub-licensing, renting, or leasing any portion of the Software, or operating any of the Software on or from a network or mainframe system; d) Using a previous version of the Software for which you have acquired an upgrade or update, except that for a period of thirty (30) days after you receive the upgrade or update you may use the previous version solely to convert existing documents to the upgraded or updated version. At the end of the thirty (30) days, the previous version must be deleted from the computer and the original disks must be physically destroyed. Notwithstanding the foregoing the end-user may make one (1) back up copy on a floppy disk or similar media of each copy of the Software licensed under this Agreement solely for normal back up purposes. The end-user may also load the Software onto one (1) hard disk for use in accordance with subsection 1 (a) or (b) of this Agreement. The end-user must reproduce and include any microtap copyright notices on each back up copy.
- (e) As the end-user is simply acquiring a license to use this product, it may therefore not be sold, leased or transferred to anyone without the prior consent of microtap. After written notification to microtap, the end-user may transfer all copies of the Software (including the original) on a permanent basis to another person or entity, provided that the end-user retain no copies of the Software and that any authorized transferee of the Software shall be bound by the terms and conditions of this Agreement. If the Software is an update, any transfer must include the update and all prior versions.

2. LIMITED WARRANTY OR GUARANTEE

microtap warrants that the Software will perform substantially for a period of thirty (30) days from the date of purchase; any implied warranties on the software are limited to thirty (30) days.

3. YOUR CONTRACTUAL REMEDIES

microtap's entire liability and the end-user's exclusive remedy shall, at microtap's option, be either (a) return of the price paid for the software or (b) repair or replacement of the software that does not meet the above limited warranty and which is returned to microtap with proof of purchase. The limited warranty is void if the failure of the software has resulted from accident, abuse, or misapplication. Any replacement software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is the longer.

4. NO OTHER WARRANTIES

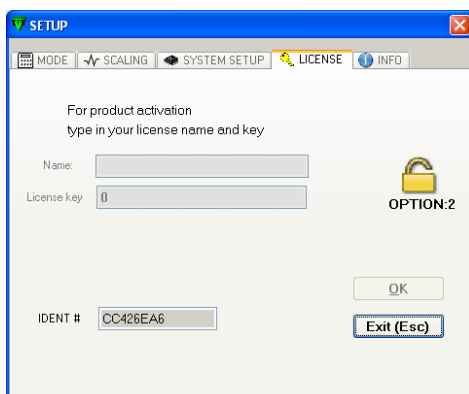
